More importantly, RegScale enhances the speed and efficiency of obtaining and maintaining Authority to Operate (ATO), providing a pathway to a Continuous ATO (cATO) process. This ensures that systems remain compliant and secure over time without the need for periodic re-authorizations.

4 Future-Proof Security Posture:

The cloud-native, compliance-as-code platform supports on-premises, classified, or air-gapped networks and is designed to adapt to evolving security threats and compliance requirements. RegScale also ensures that the DoD's security posture remains robust and up-to-date by leveraging OSCAL-native functionality, which allows machine-readable and self-updating documentation.
